THIS MEMORANDUM OF AGREEMENT is made and entered into this 21 day of October, 2015, effective as of September 5th, 2014 (hereinafter, "Effective Date"), by and between RS Parker Homes, LLC (hereinafter referred to as "RSP") and Atlantica Beach Club, LLC (hereinafter referred to as "Club").

WITNESSETH:

WHEREAS, RSP and Club have entered into a Use and Access Agreement Relating to Atlantica Beach Club of even date herewith (hereinafter the "Use Agreement"), whereby Club has agreed to grant membership in its beach club facilities ("Beach Club") to the owners of units within the residential community ("Community") that RSP intends to develop upon the property described in Exhibit A ("Property") which is hereby incorporated by reference; and

WHEREAS, pursuant to the Use Agreement, RSP has agreed to include mandatory Beach Club membership provisions in the declaration of covenants that shall be filed to govern the Property; and

WHEREAS, it is the desire of the parties hereto to execute a memorandum of said Use Agreement to be recorded in the public records:

NOW, THEREFORE, in consideration of the foregoing, and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged by RSP and Club, the parties hereto do hereby acknowledge the following terms contained in the Use Agreement:

- 1. <u>Term:</u> The Use Agreement shall remain in effect for an initial term of ten (10) years beginning on January 1, 2015 (hereinafter, the "Commencement Date") and shall be automatically extended at the expiration of such initial term for successive periods of five (5) years each, unless and until terminated by either party by written notice to the other in accordance with the terms and provisions of the Use Agreement.
- 2. <u>Mandatory Membership</u>: Each owner of a residential unit (an "Owner") within the Community shall be a member of the Beach Club by virtue of owning said residential unit.
- 3. <u>Membership Dues</u>: The Use Agreement requires payment of monthly membership dues by each Owner, which shall be paid in advance by the owners' association governing the Community and assessed by said association as an expense thereof. The assessment for membership dues shall be enforceable by the lien rights of the association.
- 4. <u>Initial Capital Contribution</u>: Membership in the Beach Club requires a one time
